

**Ordinance Number 2020-5**  
**2020-21 FY ANNUAL APPROPRIATIONS ORDINANCE**

AN ORDINANCE OF THE CITY OF LEWISVILLE, IDAHO ENTITLED ANNUAL APPROPRIATIONS ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021 APPROPRIATING THE SUM OF **\$760,000.00** TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF LEWISVILLE FOR THE COMING FISCAL YEAR, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

**Be it ordained by the mayor and the City Council of the City of Lewisville, Jefferson County, Idaho:**

**Section 1:** That the sum of **\$760,000.00** be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Lewisville, Jefferson County, Idaho for the fiscal year beginning October 1, 2020.

**Section 2:** The objectives and purposes for which each appropriation is made, and the amount of each object and purpose is as follows:

<i>General Maintenance</i>	6,620.00
<i>Library</i>	5,500.00
<i>Payroll</i>	49,000.00
<b>Total General Fund</b>	<b>\$102,895.00</b>
<b>Road Fund</b>	<b>17,700.00</b>
<b>Broadband Installation (Grant)</b>	<b>628,500.00</b>
<b>Capital Investment</b>	<b><u>10,905.00</u></b>
<b>TOTAL</b>	<b>\$760,000.00</b>


**Section 3:** That a general tax levy on all taxable property within the City of Lewisville be levied in an amount allowed by law for the general purposes of said City, for the year beginning October 1, 2020.

**Section 4:** All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.


**Section 5:** This ordinance shall take effect and be in full force upon its passage, approval and publication in one issue of the Jefferson Star, the official newspaper of the City of Lewisville.

**PASSED** under suspension of rules upon which roll call vote was taken and duly enacted an Ordinance of the City of Lewisville, Jefferson County, Idaho at a convened meeting of the City of Lewisville City Council on the 12th day of August, 2020.
