

MINUTES
CITY OF LEWISVILLE REGULAR CITY COUNCIL MEETING
Tuesday, November 15, 2022
Lewisville Community Center, 3451 E 480 N, Lewisville, Idaho

The meeting was called to order by Mayor Thomas at 7:02 p.m. at the Lewisville Community Center at 3451 E 480 N, Lewisville, Idaho. Present were Mayor Curtis S. Thomas; Council Members James Ball, Brigham Briggs, and Celena Lewis; Clerk/Treasurer, Donetta Fife and a resident. City Attorney Kris Meek and two officers from the Jefferson County Sheriff's Office had been to the City Council meeting that was scheduled for November 9, 2022 which was not held due to the lack of a quorum. That meeting was rescheduled for November 15, 2022 and an Agenda was published.

COMMUNITY CENTER:

- Eva Ball reported to the Council on the completion of the project to install the acoustical tile in the Community Center. They made sound recordings before and after the installation and noted a significant difference in the echo in the room.
- The Council commended her on a job well done.

MINUTES:

- Minutes for the City Council Meeting held October 12, 2022 had previously been distributed by the Clerk. Celena moved that the Minutes be approved, James seconded, motion passed.
- Minutes for the City Council Work Meeting held November 3, 2022 had previously been distributed by the Clerk. James moved that the Minutes be approved, Celena seconded, motion passed.

POLICE REPORT

- The Jefferson County Sheriff's Report had been distributed showing the period covered from September 17, 2022 through October 14, 2022 with 86 hours spent within the City, 11 complaints, no arrests, 3 citations and 33 traffic contact. Officers were at the meeting on November 9, 2022 but were not in attendance tonight.
- The question on the enforceability of the Jake Brake Ordinance passed at the November 2022 meeting was discussed.

BUILDING PERMITS:

- Russ and Linda Dial were not able to be attendance but had submitted their paperwork to the Clerk. She distributed the plans and site plan for review by the Council. All paperwork was in order. James moved to approve the Clearance for a building permit for Russ and Linda Dial in the Countryside Meadows Subdivision, Brigham seconded, motion passed.

MAINTENANCE REPORT:

- Mayor Thomas indicated that the hydraulics on the snow plow have been fixed and it is in working condition for winter. We will need additional cinders eventually but are all right for now.
- We are still looking for a maintenance person.

ATTORNEY:

- City Attorney, Kris Meek, had submitted a revised Resolution 2022-02 identifying the placement of signs informing of the Air Compression Ordinance within the City. The Council determined the placement of 11 signs on the map which will be attached to the ordinance.
- James moved to approve the map indicating the locations for the 11 signs as marked in red on the map, Brigham seconded, motion passed.
- James moved to approve Resolution 2022-02 for placement of the compression brake ordinance signs with the map indicating placement of said signs, Brigham seconded, motion passed.

CLERK/TREASURER:

- Donetta presented a list of all bills between October 13, 2022 and November 9, 2022. James asked for clarification with regard to the Direct Communications telephone bill. Donetta will contact them. James moved that the bills be paid, Celena seconded, motion passed.
- An error was made on the Lewisville Fall News Postcard on the size of building needing a building permit. It noted feet squared rather than square feet. A notice of the correction was posted on the website. All other documents refer to the 200 square feet size requirement for building permits.

MAYOR REQUEST:

- The Council reviewed the redrafted Exhibit C to the Area of Impact Agreement with Jefferson County. They feel it would be beneficial to attach the whole Dog Ordinance to the Exhibit C as an attachment.

OTHER:


- The Council will send condolences to Councilman Blake Ball for the loss in his family.

ADJOURNMENT:


James moved that the meeting be adjourned at 8:00 p.m., Celena seconded, motion passed.
