

**MINUTES**  
**CITY OF LEWISVILLE SPECIAL CITY COUNCIL MEETING**  
**AND BUDGET HEARING**  
Wednesday, August 17, 2022  
Lewisville Community Center, 3451 E 480 N, Lewisville, Idaho

Meeting was called to order by Mayor Curtis Thomas at 7:07 p.m. at the Lewisville Community Center at 3451 E 480 N, Lewisville, Idaho. Present were Mayor Curtis Thomas; Council Members Celena Lewis and Brigham Briggs; James Ball was in attendance via Zoom; Clerk/Treasurer, Donetta Fife and one resident.

**PUBLIC HEARING ON FY 2023 BUDGET:**

- Mayor Thomas opened the hearing.
- Clerk/Treasurer, Donetta Fife provided copies of the proposed Budget for FY 2022-2023 which had been posted on the City's website and published in the Jefferson Star. Copies of the proposed Budget for FY 2023 were made available to those in attendance. Donetta explained the proposed income and expenses. The budget income figure included \$110,000 of ARPA funds which had been received by the City in FY 2021 and FY 2022.
- Public input was received and questions were answered. Mayor Thomas asked for pro, then neutral, then negative comments. There were none.
- James moved to approve the proposed budget for FY 2023 at \$282,400.00 to defray expenses, Celena seconded, motion passed.
- James moved to close the hearing on the Budget, Celena seconded, motion passed.

**ORDINANCE 2022-2 the FY 2022-2023 ANNUAL APPROPRIATIONS ORDINANCE:**

- James moved to suspend the rules of reading the Annual Appropriations Ordinance for FY 2022-2023, Ordinance 2022-2, on three different days and once in summary in accordance with Idaho Code 50-902 and to read Ordinance 2022-2 only once in summary, Brigham seconded. Roll call vote: James – yes; Celena – yes; Brigham – yes. Motion passed.
- Brigham read the summary of Ordinance 2022-2, the Annual Appropriations Ordinance for FY 2023 setting the annual budget for the City of Lewisville at \$282,400. Celena moved to adopt Ordinance 2022-2, Brigham seconded. Roll call vote: Brigham, yes; Celena, yes; James, yes. Motion passed.

**ANNUAL FEE SCHEDULE FOR THE CITY OF LEWISVILLE FOR FY 2023:**

- Mayor Thomas presented the proposed fee schedule for FY 2023 and noted that no changes had been made from the fee schedule for FY 2022.
- Celena read Resolution 2022-1 adopting the FY 2022-2023 Fee Schedule as the official schedule of fees charged within the City of Lewisville, Idaho.


