

MINUTES  
City of Lewisville Regular City Council Meeting  
April 10, 2019

Meeting was called to order by Mayor George Judd at 7:08 p.m. at the Lewisville Community Center at 3451 E 480 N, Lewisville, Idaho. Present were Mayor George Judd; Council Members, Del Heward; Leisa Watkins and James Ball; City Attorney, Kris Meek; Officer Mike Miller from the Jefferson County Sheriff's Department; Maintenance Supervisor, Gary Wilde; Clerk/Treasurer, Donetta Fife and residents Darwin and Sharon Casper, Brigham Briggs and Terry Fife.

**ROLL CALL:**

**MINUTES:**

- Minutes for the regular City Council meeting held March 13, 2019 had previously been distributed by the Clerk. Mayor Judd asked if everyone had received the minutes, all had. Leisa moved that the Minutes be approved, Del seconded, motion passed.
- The Minutes for the Special City Council Work Meeting held March 28, 2019 had previously been distributed by the Clerk. Mayor Judd asked if everyone had received the minutes, all had. The Clerk explained the modification to the minutes. Leisa moved that the minutes be approved as amended, James seconded, the motion passed.

**POLICE REPORT:**

- Officer Miller reviewed the police report between February 9, 2019 and March 8, 2019. There were 73 hours patrolling with 13 calls, no arrest, 7 citations and 27 traffic stops. There was a vicious animal complaint and a tool theft. James asked about the Ball property break in and Officer Miller said he would check on the status and get back to him.

**MAINTENANCE REPORT:**

- Gary reported that it has been pretty slow lately with the snow gone. There are still tree sections near Balls. James will contact someone to move them and will have them contact Gary. The traffic speed sign still has not been moved. Officer Miller will check on that.
- The Mayor reported that he will use cold patch to fill in the holes and then when we find someone to help with the dura patch, we will work to repair the rest of the damage.
- The street sign on 480 North by the Church has been broken off near the ground. Gary will check on replacing it.
- Donetta checked with the Mayor on the Tru Green Contact. She will send it to him for a signature.

**VISITORS:**

- Darwin and Sharon Casper addressed the problem of an excessive number of goats on the properties across the street from them. They feel there is a sound and smell problem and that the goats are not always in the fence and sometimes come onto the Casper property. There is also refuse in the right of way and drainage. They have had a real estate agent appraising their

property and he indicated that the property would be less saleable with all of the goats next to them. The Mayor indicated that he had spoken with the Briggs family and set the limit of animals to 13 adult female or castrated males for their 2.25 acres of grazeable ground. Sucklings over the age of 6 months are considered adult. No Billie goats are allowed. If the goats are on the Casper's property again, they should call the Sheriff's Department and ask them to come out. They will need to be willing to sign a complaint.

- Brigham Briggs appeared and asked what he needs to do to be in compliance with the Code. He does not want to have his operation be offensive to the neighbors and the City. The Mayor is trying to work with citizens prior to the time a citation is written.

#### **CITY ATTORNEY:**

- City Attorney, Kris Meek noted that the only current case the City has is the Smith case and she has been given a 30-day period to meet all code requirements.

#### **CLERK/TREASURER REPORT:**

- The Council reviewed the list of bills that have been presented to the City between March 14, 2019 and April 9, 2019. There were no questions on the bills. James moved that the bills be paid, Leisa seconded, motion passed.
- AIC Spring Training April 23, 2019 at the Shilo. The Mayor, James and Donetta will be going.
- The disposition of monies on the Smith fines was discussed. Donetta will check with the County Clerk's office to see where that money has gone.
- The Easter Egg stuffing party was scheduled for April 17, 2019 at 6:30 p.m. at the Community Center. The Easter egg hunt will be Saturday, April 20, 2019 at 10:00 a.m.
- Jefferson County - City of Rigby public input meeting will be April 16, 2019 at 7:00 p.m. at District 251 office.
- JustServe wants us to see if there is anything families and individuals can do as service projects in our City. It was suggested that we could use help stuffing Easter eggs on Wednesday and that people could clean the right of way of debris before mowing season. Also, if anyone wanted, they could work on tree removal and cleanup.


#### **MAYOR REQUEST:**

- James indicated that he had a bid on his fence that a was broken with a falling tree limb. Kris suggested that we check with ICRMP to see if that falls under our policy with them and will it cause an increase in our yearly insurance premium rate.
- The Council went over the library addition blue prints. They had a few suggestions that would be easier to install now than after it is built. James will talk to the architects. Meyers Anderson plans to have a sealed bid. Kris clarified what Idaho Statute says should be done on the bid. They will need to clarify the procedure.
- The bid for new commercial heaters in the bathrooms at the Community Center was \$1,300. Del suggested that we get another bid for them as we are not facing very cold weather for a while.

#### **ADJOURNMENT:**


James moved that the meeting be adjourned at 8:59 p.m., Leisa seconded, motion passed.
