

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Lewisville City Council will hold a public hearing at the Lewisville Community Center, 3451 East 480 North, Lewisville, Idaho, on the 8th day of September, 2021 at 7:00 p.m. to receive public input on the modification of Section 8-5-8 of the Lewisville Idaho City Code setting forth standards for housing livestock and small domestic animals in residential and commercial zones within the township of Lewisville as follows:

- A. Livestock shall be allowed provided the lot has at least one-half acre of dedicated ground where animals are kept. Animal units per acre of dedicated ground are established on the livestock quantity per animal unit chart.

- B. Small domestic animals shall be allowed provided the lot size is at least one-quarter (1/4) acre in size, not to exceed 25% of one animal unit.
- C. Waste piles are required to be at least fifty feet (50') from all property lines. Facilities for housing all animals shall meet auxiliary building setback.
- D. Animals must be kept in a manner as not to constitute a nuisance or health hazard.
- E. Action for noncompliance may be brought by the City or any resident. Violations will be prosecuted as infractions and misdemeanors.
